**Application Start Date:** March 1, 2018  
**Deadline to Apply:** August 12, 2018 (except new families)  
**Award Notifications:** Applicants will be notified by August 14, 2018  
**Maximum Financial Aid:** 80% of Tuition and Fees

**Requirements To Be Completed by May 5<sup>th</sup>:**

1. Must complete the FACTS Aid Assessment online and provide all supporting documentation <https://online.factsmtg.com/signin/4GVQP>
2. Must complete and submit a Dillon Scholarship application (available at school office)
3. Must qualify for reduced or free lunches per federal guidelines (available at school office)
4. All past due tuition and fees need to be resolved before any financial aid can be awarded. Contact Fr. Sullivan
5. Must be a stewardship family - fulfilling stewardship pledges of time, talent, and treasure. Contact Fr. Sullivan
6. After completing the above requirements you are responsible for contacting the Fr. Sullivan to schedule an appointment prior to **August 10<sup>th</sup> for returning families or prior to enrollment for new families.**
